Instructions to authors

Bulletin of the Société de pathologie exotique which publishes articles mostly in French, wants to be more open to the English language and also accepts submissions of articles in English.

Every article sent for publication is registered and submitted to the Editorial Board which examines and addresses it to two specialized external reviewers if considered in accordance with the editorial line of the issue.

A complete address must be provided (telephone and fax numbers, e-mail); the registration number of the article must be cited in all subsequent correspondence.

If the article has been co-authored, the written agreement of all authors must be enclosed in the first dispatch of the text. Confirmation that the article has not been submitted elsewhere for publication is also required.

Authors are asked to provide to the Editorial office, preferably by e-mail (bulletin@pathexo.fr) the text file (tables included) and the original files of figures and photographs.

Documents of all kinds (text, illustrations) imply the publication and reprinting agreement by the Bulletin only, except in the case of a special prior agreement between author and publisher.

1 - Manuscripts

• Articles

The number of pages for each article submitted to the review must not exceed 12 (including illustrations, references and abstract), i.e. 15,000 to 25,000 signs, except in exceptional circumstances with the agreement of the editorial board.

The abstract (ten typed lines), keywords (five), and the translation into English of the title, abstract (which should be longer than the French one), keywords, titles of figures and tables must be attached. Original articles should be presented with an English structured abstract (Aims, Procedure, Results, Conclusion).

• Short notes

Short notes should total 80 typed lines, plus an abstract and keywords (in English and French), four bibliographical references, possibly one or two tables or photographs.

• Proceedings (congresses, external meetings, and affiliated societies)

The summaries should be 2,500 characters long (without spaces). Bibliographical references and one or two tables or images can be attached.

• Solicited or editorial articles

Solicited or editorial articles are subject to a special agreement between the Editorial Board and the author(s).

• Opinion column

Texts may be published under the sole responsibility of the author, possibly accompanied by an opinion from the Editorial Board or reviewers.

2 - Iconography

• **Tables:** they should not exceed a total of 4, and

should be numbered in Arabic numerals and be described by a title in both language (French and English) and possibly a legend.

• **Figures:** figures should be numbered in Arabic numerals, be of excellent quality, possibly on native file in order to ensure satisfactory reproduction and be described with a title (in French and English).

• Photographs

Photographs must be provided on computer support (on a separate file) and, as the figures, they should be of excellent quality (resolution: 300 dpi). They will be reproduced in black and white in the issue and in colors on the SPE website and on Springerlink.

3 - List of references

The references are listed in alphabetical order. References are composed as follows: a number, indicated in the text in square brackets; the author's surname, followed by the initial of the first name; the year, the title of the publication, the abbreviation of the title of the issue according to the *Index Medicus*; the volume number; the first and last page (see example below). Cite all authors when they are four or fewer, otherwise cite the first three, followed by et al.

4 - Ethical standards declaration

Authors indicate that all their experiments on human subjects published in this article are in accordance with these standards.

In case of any doubt, the authors agree to explain the rationale for their approach, and demonstrate that the institutional review body explicitly approved the doubtful aspects of the study. When reporting experiments on animals, authors will indicate whether the institutional and national guide for the care and use of laboratory animals was followed.

Further, *Le Bulletin de la Société de pathologie exotique* fully adopts and supports the standards of the International Committee of Medical Journal Editors.

Authors agree to handle the statement of informed consent as indicated in the instructions to authors with regards to privacy and confidentiality of patients mentioned in the text. When informed consent has been obtained it will be indicated in the published article.
